- "At baseline, 6.1% (2/33) people had moved into a place of their own. At the 6-month follow-up, 93.3% (14/15) people had moved into a place of their own"
- At baseline, 100% (33/33) of people reported to no longer be staying where they were (moved), at the six months follow up, 93.3% (14/15) of people said they are still in the location after being placed. (Stable housing)
- "At baseline 15.5% (5/32) people reported to feel safe in their neighborhood. At the 6-month follow-up, 86.7% (13/15) people reported to feel safe in their neighborhood"
- At baseline, 47.6% (10/21) of people, reported to feel dissatisfied with where they live. At the 6-month follow-up, 60% (6/10) of people felt satisfied and 40% (4/10) of people felt very satisfied.
- At baseline, 6.1% (2/33) of people, felt very satisfied with the ease of their transportation. At the 6-month follow-up, 46.7% (7/15) of people felt very satisfied, and 33.3% (5/15) of people felt satisfied. However, the remaining 20% of people feel unsure abut the ease of transportation. Perhaps, information regarding transportation isn't as accessible as it could be? (Just a random thought of mine)
- At baseline, 21.2% (7/33) of people reported using Supplemental SSI as a source of income and at the six months follow up 60% (9/15) of people said to have used this as a

source of income. *** it may only be two more people; however, I think it's noteworthy to commend those who managed to help assist those two people.

- At baseline 15.2% (5/33) people reported using other social welfare benefits as a source of income and at the six months follow up 66.7% (10/5) of people reported having used these recourses in the last six months. That is double the number of individuals from the start, Great work!!
- At baseline 100% (33/33) of people did not use rent supplements as a source of income, and at the six-month follow-up 93.3% (14/15) of people reported that they now were using these recourses available. Great work!!!!
- At baseline 54.4% (18/33) of people reported to not have enough money for food each month, and at the six-month follow-up 100% (15/15) of people reported they all had enough money for food during the month. Excellent work!
- At baseline 69.7% (23/33) of people reported to not have enough money for clothing. At the six-month follow-up 100% (15/15) of people reported to have enough money for clothing. Awesome job!!!
- At baseline 93.9% (31/33) of people reported to not have enough income for housing. At the six-month follow-up 93.3 % (14/15) of people reported to have enough recourses to pay for housing

- At baseline 12.1% (4/33) people felt they had enough money to travel around to see friend family etc., and at the six-month follow-up 86.7% (13/15) of people enrolled felt they did have enough.
- At baseline 18.2% (6/33) of people felt they did not have enough money for social activities, and at the six-month follow-up 66.7% (10/15) felt they did have enough money for social events.
- At baseline, 45.5% (15/33) of people reported to have been evaluated by medical professionals in the last six months. At the six-month follow-up 6.7% (1/15) of people reported being seen by emergency medical professionals
- At baseline, 57.6% At Follow-up, 6.7% (1/15) people said they had interactions with police in the last six months. The one person who reported to have interactions, reported all interactions went well, with no force being used.
